- 2 Class meets for seven (7) weeks, starting week of January 9, 2012.
- 3 Enrollment limited to thirty (30) students.
- 4 Class meets for two (2) consecutive semesters. Prerequisite: Evidence I.
- 5 Prerequisite: Immigration Law.
- 6 Externships are open to students who have satisfactorily completed all first year courses, are in good academic standing, and have a grade point average of at least 2.00. Subject to securing a placement, eligible students may enroll in 2 to 6 (2-6)credits in the Fall and Spring Semesters. Maximum of 12 externship credits may be earned in externship placements.
- 7 Prerequisites: Real Property I & II.
- 8 Enrollment limited to students on Law Review. All members of Law Review who are third or fourth year students must register for this course.
- 9 Enrollment limited to twenty (20) students.
- 10 Prerequisite: Evidence. 11 Prerequisites: LWRA I & II.
- 12 Enrollment limited to sixteen (16) students.
- 13 Enrollment limited to eighteen (18) students.
- 14 Enrollment limited to twenty-two (22) students.
- 15 Prerequisites: Constitutional Law I & II.
- 16 Prerequisite: Criminal Law.
- 17 ADR & Writing (225) is NOT available for students who have taken/are registered to take/plan to take Mediation (622); and vice versa.
- 18 Enrollment limited to twenty-five (25) students.
- 19 Enrollment limited to twenty-five (25) students. Priority given to graduating students.
- 20 Enrollment limited to twelve (12) students.
- 21 Prerequisites: Constitutional Law, Criminal Law, and Criminal Procedure.
- 22 Prerequisite: Criminal Law, Criminal Procedure.
- 23 Satisfies the upper level writing requirement.
- 24 Class meets for three (3) weeks, starting the week of January 9, 2012.
- 25 Prerequisite: Wills, Trusts & Estates.
- 26 Enrollment limited to eight (8) students.
