1. A completed visiting student application

2. An official transcript of all prior law school coursework sent directly from the school to the Office of Admissions;

3. Ensure a current CAS report is available for retrieval;

4. A letter of good standing from the home law school clearly stating that credit for classes undertaken at the law school will be applied to the applicant's degree at their home school.

In addition to a bar examination, there are character, fitness, and other qualifications for admission to the bar in every U.S. jurisdiction. Applicants are encouraged to determine the requirements for any jurisdiction in which they intend to seek admission by contacting the jurisdiction. Addresses for all relevant agencies are available through the National Conference of Bar Examiners.
