2. Submit the nonrefundable application fee of \$25 with your application.
3. Request official transcripts from all undergraduate schools attended. Transcripts should be sent by those law schools directly to LL.M. Admissions or through Law School Admission Council. Please note that a Bachelor's Degree from a regionally accredited institution is required and your application will not be processed until we receive a copy of your transcript indicating a conferred Bachelor's Degree.
4. Request a minimum of one letter of recommendation be sent directly to the school.
5. If applicable, request official transcripts from all law schools attended. Transcripts should be sent by those law schools directly to LL.M. Admissions or through Law School Admission Council.
