- 1. Complete, sign, and date this application form.
- Submit a 2-3 page personal statement (as an electronic attachment) with this application form or as an email attachment to <u>admissions@johnmarshall.edu</u>.
- 3. Submit a 1 page resume (as an electronic attachment) with this application form or as an attachment to <u>admissions@johnmarshall.edu</u>.
- 4. Applicants must have a reportable Law School Admission Test (LSAT) score. Applicants for the Fall 2019 entering class must take the LSAT no later than the June 2019 test administration and are encouraged to register for an earlier administration.
- 5. Request official transcripts from all colleges and universities to be sent to the Law School Admission Council (LSAC). All applicants must register with the LSAC Credential Assembly Service (CAS) and have a Credential Assembly Service Law School Report sent to the Law School. Transcripts of all academic work, including undergraduate, graduate and professional schools, must be sent to LSAC.
- 6. Have two letters of recommendation that address the applicant's character, academic ability, and potential for the study of law sent to LSAC or directly to the Law School.

In addition to a bar examination, there are character, fitness, and other qualifications for admission to the bar in every U.S. jurisdiction. Applicants are encouraged to determine the requirements for any jurisdiction in which they intend to seek admission by contacting the jurisdiction. Addresses for all relevant agencies are available through the National Conference of Bar Examiners.
