



Application Instructions

1. Complete, sign, and date this application form.
2. Submit a 2-3 page transfer statement (as an electronic attachment) with this application form or as an email attachment to admissions@johnmarshall.edu.
3. Submit a 1 page resume (as an electronic attachment) with this application form or as an attachment to admissions@johnmarshall.edu.
4. Request official transcripts from all colleges and universities to be sent to the Law School Admission Council (LSAC). All applicants must register with the LSAC Credential Assembly Service (CAS) and have a Credential Assembly Service Law School Report sent to the Law School. Transcripts of all academic work, including undergraduate, graduate and professional schools, must be sent to LSAC.
5. Submit an official transcript of all prior law school work, sent to the LSAC or to the law school directly.
6. Two letters of recommendation, at least one of which must be from a law professor who taught the applicant.
7. Submit a letter of good academic standing from the Dean of the law school you are transferring from.
8. Per Section 306 (b) (2) of the Dean's Office Regulations in the Student Handbook, upon acceptance, transfer students must apply to the Associate Dean of Academics, in writing, by filing a petition for the requested transfer credits.

In addition to a bar examination, there are character, fitness, and other qualifications for admission to the bar in every U.S. jurisdiction. Applicants are encouraged to determine the requirements for any jurisdiction in which they intend to seek admission by contacting the jurisdiction. Addresses for all relevant agencies are available through the National Conference of Bar Examiners.
