

The Honors Program in Criminal Justice curriculum prepares graduates to practice criminal law, whether as a prosecutor or a defender. Core components of the Program approach include:

- 1. **Integration** Students appreciate how all of the courses in the criminal law curriculum relate to one another and to the larger practice of law;
- 2. **Application** Students not only understand these lessons in theory, but learn how to apply these lessons to situations they will encounter in their practice;
- 3. **Reality Based** Students not only learn the ideals that underscore any criminal law curriculum, but also understand how the criminal justice system works in reality.

Students graduate equipped with strategies to allow them to shape the criminal justice arena rather than simply being shaped by it. The Honors Program in Criminal Justice provides an integrated, applied approach to legal education that equips our students with the necessary strategies to be ethical, professional, and moral lawyers in less than perfect systems. At least 2 additional elective credits must be a criminal law skills course. Criminal law skills courses include Advanced Criminal Appellate Advocacy, Criminal Pretrial Practice and Procedure, Advanced Trial Advocacy, Client Counseling for the Criminal Lawyer, Negotiations in the Criminal Context, and The Art of Voir Dire. These two credits must be in addition to the upper level writing requirement. Students enrolled in the L.D. Honors Program in Criminal Justice are not required to take Sales & Secured

Students enrolled in the J.D. Honors Program in Criminal Justice are not required to take Sales & Secured Transactions, but may do so as an elective.
