**Thursday, July 9, 2026, at 11:59 p.m. EST**

### **INSTRUCTIONS**

- You must be currently enrolled at Atlanta's John Marshall Law School for the Fall 2026 semester and return to Atlanta's John Marshall Law School for the Fall 2026 semester to be eligible for scholarships. **Funds for these scholarships will not be posted to recipients' accounts until after the drop/add period of the Fall 2026 semester and cannot transfer to another law school.**
- Our process is online. Please allow focused time to complete applications, write and review required essays, request recommendations, and follow up with recommenders. All scholarship applications will disable at **11:59 p.m. EST on Thursday, July 9, 2026**. We will not consider late or incomplete applications. **We will only consider applications that are submitted through our online process. You MUST be logged into your AJMLS Email to access and submit the application.**
- Carefully review available scholarship opportunities and determine the scholarships for which you meet the criteria. Apply only for the scholarship(s) in which you meet all the listed criteria. If you do not meet all the requirements, you will not be considered.
- All scholarship applications will require a resume. Please review each application to view additional requested information. If you do not submit all required documents, you will not be considered.
- Most available scholarships require essays as part of the application process. We advise applicants to write all essays in a word processing software. Additional Letters of Recommendations must be in a PDF format.
- Please do not type your application or essay responses in all caps or all lowercase. Please use correct spelling and grammar.
- We recognize that artificial intelligence (AI) tools can be valuable. However, scholarship applications are intended to reflect your personal experiences, perspectives, and voice. Applicants are expected to submit responses that are their own original work. **While limited use of AI for light editing or proofreading may be acceptable, reliance on AI-generated content to draft or substantially compose your responses is discouraged and will impact your selection for scholarships.**
- **What happens after I submit a scholarship application? When will scholarship recipients be notified?**  
The application system will send you an automatic confirmation email with a copy of your application. Due to the volume of applications we receive, we **cannot** respond to individual requests for updates. Scholarship recipients will be notified by email in August.
