Chapter 17

Discuss other lawyers' joke that Haller married to create a conflict Why would police have extra enjoyment booking Haller? Is it ok for Haller to get free rent on the storage unit in exchange for attorney fees?

Is Haller a good lawyer? Would any lawyer have recognized the victim photo similarity?

Is it a coincidence that Haller was selected as the lawyer for both cases?

Chapter 18

Why does Haller be sure to note that Menendez made police statement, "before I was the lawyer"?

What is "iceberg" evidence?

Is it ok for Haller to take on case as a loss leader, looking for media exposure Why is language barrier important in the Menendez case?

What did client assume when lawyer never asked if he was guilty? What did Haller think when Menendez would not shake hands? Would you feel the same way Haller felt on the train?

Chapter 20

What is important about Corliss being given a deal? What are assumptions Haller makes about Corliss? Prosecutor? What do you think about Haller's heavy drinking that night after talking to Levin? What do you think of Haller's explanation of his ethics to Levin?

What do you think of Haller's descriptions of his house payments being dependent on his case load?

What do you think of Maggie's residence as a factor in her getting promoted? How about her being passed over because she was too good/too fair/too honest? Does that happen?

What are thoughts on client's offer to double fees after acquittal? How does victim's safety affect attorney client privilege? What about client's statement that Haller has a beautiful daughter?

What do you think Haller was trying to say when he said "I can't do this anymore"

Read Chapters 3 and 4 Textbook

Discussion topics from reading material:

Explain Attorney-Client Privilege to client and discuss waiver issues Explain Conflict of Interest to client and discuss waiver issues Explain Retainer to client and discuss fee arrangement with client Discuss office personnel role in taking initial phone call from client and what legal advice they can discuss; Discuss Initial office visit with client; Discuss choice of vocabulary you would use with client Discuss how to explain your legal assessment of case with client Discuss with client their objectives with regard to representation

Explain initial course of action to client and follow up meeting

Week 13 Read Chapter 4 Textbook

Discussion topics from reading material:

Discuss how summary judgment, closing arguments, and settlement should be used by the attorney at the initiation of representation What is active listening? Demonstrate

How can the first year of law school help attorney to communicate with client? What phrases can be used to communicate effectively when discussing difficult subjects? What are common barriers to communication? How can they be overcome? What is difference between open and leading questions? Why would each be used? What is Funnel Technique? Is it useful?

What is Funnel Technique? Is it useful?

How can attorney achieve client expectations during interview? Be prepared to demonstrate skills discussed in Chapter Four in class interviews.

Week 14: Read Chapters 5 and 6 Textbook

Discussion topics from reading material:

Discuss process of decision making on page 63 What are non-legal factors? Are they important? How can attorney assign probabilities of outcomes? How can decision be implemented if client is unreasonable? How can attorney help in crisis decisions? Be prepared to counsel client through a decision

How important are lawyer ethics to decision making decisions for clients? Give examples from recommended cases and required cases where clients may have been harmed by lawyer conduct. Is lawyer harmed in other future cases? How important is written fee contract and scope of representation contract? Discuss Competence, Diligence and Communication roles of attorney. How much of attorney advice should be in writing? Why? How do you represent mentally disabled clients? How important is client confidentiality? How should representation be declined or terminated? How important are Conflicts of Interest? How is Attorney authority for settlement determined? Discuss Contingent fee arrangements.

Also, be prepared for final client interview to last 5-10 minutes (details of case to be provided by professor)
